Notice for the Population Census

The Population Census will be taken simultaneously throughout the country as of 1 October 1955. In Japan the Population Census has been conducted every five years since 1920, in order to obtain essential data for national activities by enumerating characteristics of the population.

In this Census, all persons who usually reside in your household are to be covered. The head of household (or the representative of household) is requested to enter "Name", "Relationship to Head", "Sex", "Date of Birth", "Marital Status" and "Citizenship (Nationality)" for all members of household in each of the "Columns to be filled up by the head of household" (left side of the back) after reading through the instructions given in the schedule carefully.

"Columns to be filled up by the enumerator" is to be done up by the enumerator himself upon interview. Your cooperation is earnestly desired in preparing answers to the interview.

The information obtained from the Census is to be used only for the purpose of compiling statistics, and is forbidden by law to utilize for taxation and/or other purposes. You are sincerely requested to report frankly.

Read this through before filling up your form

Who shall fill up this form?

- In the case of an ordinary household, the head of the household shall fill up in behalf of all the members of his household. In case the head is absent, his wife or his son or any other person máy do it.
- In the case of a dormitory or boarding house, a representative, chosen from among it's inmates, shall fill up this form for all inmates.

- In the case of an ordinary household, family mem-bers who share living expenses together, employees-living-in and free boarders are included.
 - However:
 - Those who belong to the following categories shall be enumerated separately.

 (a) Family members who reside eisewhere.

 (b) Family members who reside in the same house but maintain a separate budget.

 (c) Lodgers such as roomers and boarders who pay for room and/or board.
- In the case of a dormitory or boarding house, where two or more persons residing together but maintain-ing separate budgets, all inmates (including man-ager and employees not living with families) shall be reported together in one group as one household.
 - Manager, employees and boarders of a dormitory, etc., who live with their families and maintain separate budgets, shall be reported with their families in one group as separate

- Persons who have been away for less than three months from their households due to travelling or working elsewhere, must be reported at their homes. Absentees for more than three months shall be reported at the places where they stay on 1 October.
- The following are special cases and shall be report ed at the places specified below:
 - Students and pupils living away from home in dormitories or boarding houses shall be report-ed at the dormitories or boarding houses, not
 - Hospitalized patients shall be reported at the hospitals if they have been there for more than three months. If not, they shall be reported at
 - Crews aboard ships shall be reported at their homes:
 - All residents of camps and of ships belonging to the National Defense Forces, shall be reported at their camps or on their ships.
 - Persons in prisons or detention houses whose penalties have been fixed shall be reported at these institutions. Those whose penalties have not been fixed shall be reported at their homes, provided they have one.
 - Persons who have no usual place of residence shall be reported at the places where they stay on 1 October.
